

# **NWRG Hub Tour: Sea the Waves in your Model A's, 2025 Long Beach, Washington**

Greetings from the Northwest Regional Model A Group. We will be hosting the Hub Tour in Long Beach, Washington. Remember, it is a Hub Tour, let's drive our "A's" and have fun!

## **Host Hotel**

The Hub of the tour will be the Chautauqua Resort & Conference Center, 304 14<sup>th</sup> St NW, Long Beach, Washington. We have a guaranteed room rate of \$109/night USD + tax. A block of rooms has been reserved for the Hub Tour beginning Sunday evening, September 21<sup>st</sup> until Friday, September 26<sup>st</sup>. ## ***Chronologically, here are the major events:***

### **September 21, 2025 (Sunday afternoon)**

We will begin early registration on the evening of September 21<sup>st</sup>, 4:00 – 6:00 p.m., at the Chautauqua Resort in Long Beach, Washington. Look for the registration table in the Sunrise Room. Open 4:00 – 6:00 p.m.

### **September 22, 2025 (Monday)**

Registration will begin at 8:00 a.m. at the Chautauqua Resort in the Sunset Room. Because most of the area hotels offer a breakfast, we will not be having breakfast.

The Welcome meeting will be in the Sunset Room at 9:00 a.m. Please attend to find out about the week's events, meet old friends and make new acquaintances. You will receive a Hub Tour booklet containing the schedule and all of the available tours listed.

### **September 23, 2025 (Tuesday)**

Touring on your own. Restorers Class Evaluations start at 9:00 a.m. Tailgate Swap Meet is from 2:00 to 4:00 p.m. Hubley check in at 4:00 pm, NWRG Representatives meeting at the Chautauqua Resort in the Sunset Room at 5:00 p.m., dinner on your own and Hubley races start at 7:30 p.m.

### **September 24, 2025 (Wednesday)**

Grand tour will include sites around SW Washington & NW Oregon and will stop at Camp 18 for lunch between 1:00 – 2:30 p.m. After lunch you will be free to tour on back roads to the Long Beach area.

### **September 25, 2025 (Thursday)**

More touring on your own and Farewell Dinner at 6:00 p.m. at the Chautauqua Resort in the Sunset Room. No-host bar will open at 5:00 p.m.

### **September 26, 2025 (Friday)**

Hotel check out and travel home.

## **Registration Form**

Print the registration form and waiver, fill them out and mail both along with your check or money order in US funds to Linda Harding, Treasurer of the NWRG, 4914 NW Springhill Drive, Albany, OR 97321. If you omit the waiver your registration will be returned. Canadian friends, please convert to US funds, at current exchange rate, and mail a money order to Linda. If you registered and attended the Hub Tour in Redmond, Oregon be sure to subtract \$50 from your registration total.

## **Trailing Your Car?**

If you're trailing your car you can park your truck/trailer at the host hotel, please park on the east side of the parking lot.

## **Name Tags**

If you have a box full of lanyard name tags from previous NWRG meets, pick out your favorite and bring it with you to the registration table. You will receive a Hub Tour name/club label to insert into your name tag. If you prefer, wear your MAFCA name tag. If you don't have either, a name tag will be provided when you register.

## **Dress Code**

The dress code will be casual throughout the Hub Tour and business casual or era fashions for the Farewell Dinner. Era wear is encouraged.

## **Hospitality**

The hospitality area will be in the Chautauqua Resort in the Sunset Room. We will provide cookies and will be serving beverages. Clubs are encouraged to bring cookies to share and offer to help staff the hospitality room. This location will be a good place to rendezvous and go over the touring schedule with your friends.

## **No Profit Raffle**

No Profit Raffle! "I've never heard of that before!" That's because Roger just made it up. Normally the raffles help the host club cover their costs. The Region has been making money on these Hub Tours so we don't need to make a profit on the raffle. All of the proceeds from the raffle will be split evenly between 3 randomly drawn clubs that are attending.

Also, as usual this will be a "Pick a Prize Raffle", that means buy some tickets and put a ticket in a bucket of something you hope to win. The winners for each item will be determined by randomly drawing a ticket from each bucket. Clubs are encouraged to bring something to donate to the raffle.

## **Tailgate Swap Meet**

Bring any Model A era items you want to sell and we'll have a section of the parking lot reserved for your Model A pickup, car or AA truck. Era fashion sellers and collectors are encouraged to participate.

## **Registration Deadline**

The deadline for Hub Tour registrations is July 21, 2025. The cost of registrations after July 21<sup>st</sup> increases so early registration is encouraged. Any cancellations after the cut off date of July 21<sup>st</sup> will only get the registration fee refunded because we've already paid for the food. Banquet registrations will be limited to 135 people.

If some unforeseen problem arises and the event has to be cancelled, your registration fees will be refunded. If we have way more than 60 registrations and make money on this event we will give you a break on the next Hub Tour.

IN CONSIDERATION OF BEING PERMITTED TO VOLUNTARILY PARTICIPATE (AT MY REQUEST) IN THE EVENT OF MODEL A FORD CLUB OF AMERICA ("MAFCA"), ITS CHAPTERS, REGIONS AND/OR SPECIAL INTEREST GROUPS REFERRED TO BELOW ("EVENT"), I/We, THE UNDERSIGNED AGREE(S) TO THE FOLLOWING:

**1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE MAFCA, ITS CHAPTERS, REGIONS OR SPECIAL INTEREST GROUPS, THEIR EMPLOYEES, OFFICERS AND AGENTS ("Releasees")** from all liability to the undersigned, his or her or their personal representatives, assigns, heirs, family members and next of kin ("**Releasors**") for any loss, damage, or claim therefor on account of injury to the person or property of the Releasors, whether caused by any negligent act or omission or other fault of the Releasees or otherwise while the undersigned is participating in the Event or using any of Releasees' facilities in connection with the Event.

**2. THE RELEASORS HEREBY AGREE TO INDEMNIFY AND HOLD HARMLESS** the Releasees from all liability, claims, demands, causes of action, charges, expenses, and attorney fees and all other costs resulting from my involvement in the Event whether caused by any negligent act or omission or other fault of the Releasees or otherwise.

**3. THE RELEASORS HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF PERSONAL OR BODILY INJURY, DEATH OR PROPERTY DAMAGE** while upon Releasee property or participating in the Event or using any Releasee facilities and/or equipment whether caused by any negligent act or omission or other fault of Releasees or otherwise. The Releasors expressly agree that the foregoing release and waiver, indemnity agreement and assumption of risk are intended to be and shall be interpreted and applied as broad and inclusive as permitted by applicable law.

**I ACKNOWLEDGE THAT I HAVE READ THE FOREGOING, THAT I AM VOLUNTARILY ENTERING INTO THIS AGREEMENT AND THAT I AM AWARE OF THE LEGAL CONSEQUENCES OF THIS AGREEMENT**, including that it prevents me, my personal representatives, assigns, heirs, family members and next of kin from suing the Releasees if I am injured or damaged for any reason as a result of participation in the Event.

**IF THE PARTICIPANT IS A MINOR, HIS OR HER CUSTODIAL PARENT OR LEGAL GUARDIAN MUST READ AND EXECUTE THIS AGREEMENT WHERE INDICATED BELOW.** I hereby warrant and represent that I am the legal guardian or custodial parent of the minor named below, who is a minor, and agree, on my own and said minor's behalf to the terms and conditions of the foregoing agreement.

I understand that I may talk to my legal advisor about this agreement and I have either done so or chosen not to. I understand that I have the right and have been given the opportunity to object to and bargain about the provisions of this agreement. I am voluntarily signing this agreement and intend it to be the unconditional release of all liability to the greatest extent allowed by applicable law.

**BEFORE SIGNING, CAREFULLY READ THIS ENTIRE AGREEMENT:** If any accident, injury, death or damage to personal property occurs, you (by signing this agreement) will be giving up certain legal rights. If any part of this agreement is held invalid, the rest of the provisions shall remain in effect. If you do not understand anything in this agreement, you should not sign it and you should instead consult your legal advisor.
